

CONDITIONS OF ENTRY

Mindil Beach Casino & Resort reserves the right to:

- 1. Approve or refuse entry to any person at any time.
- 2. Ask you to leave the premises at any time without reason, including because of inappropriate behaviour or dress.
- 3. Withdraw your right to remain on the premises without reason.
- 4. Confiscate any weapons or prohibited items.

PROOF OF AGE CHECK

Persons under the age of 18 years are not permitted in any gaming area.

Minors are permitted in restaurants until midnight when accompanied by a parent or guardian who are 18 years and over.

Persons entering or attempting to enter the casino premises forfeit to Mindil Beach Casino & Resort and entitle Mindil Beach Casino & Resort to retain identification documents which Mindil Beach Casino & Resort suspects of forgeries, falsified, tampered or otherwise fraudulent.

Liquor will not be sold to persons under the age of 18 years. Licence and conditions are available for inspection.

AUDIO AND CCTV SURVEILLANCE

Mindil Beach Casino & Resort utilises a range of surveillance tools, including facial recognition technology, which can collect and store biometric data. By entering Mindil Beach Casino & Resort premises you are consenting to Mindil Beach Casino & Resort collecting and storing this data and you agree to the use of the data for site safety and security purposes, and where appropriate, to support responsible gambling measures.

Audio and Surveillance information (including biometric data) may be disclosed to law enforcement agencies or regulatory authorities where illegal or undesirable activity is suspected.

DRESS REGULATIONS

The dress standard for Mindil Beach Casino & Resort is neat and tidy attired (including appropriate footwear) with an appropriate level of hygiene being adhered to at all times. Management's expectation is that customers utilising the facilities will wear a high standard of smart casual attire.

The following is not acceptable at Mindil Beach Casino & Resort any time:

- 1. Clothing with obscene or offensive slogans or pictures.
- 2. Clothing or colours associated with criminal organisations.
- 3. Beachwear or swimsuits within the facilities and gaming floor.
- 4. Clothing illegitimately depicting the wearer as a security operative, law enforcement officer or representative of a government agency.
- 5. Ripped, torn, or soiled clothing (Designer ripped/torn clothing acceptable).
- 6. Unpleasant levels of personal hygiene which are offensive to others.
- 7. Face paint, disguise or other attire that may inhibit visual identification.
- 8. Tattoos which are either offensive or suggest affiliation with criminal organisations.
- 9. Any other clothing deemed not to be neat and tidy by Mindil Beach Casino & Resort staff.

GAMING AREAS

Persons under the age of 18 years are not permitted in any gaming area.

The use of mobile phone/camera is permitted throughout the complex excluding gaming tables.

Large bags or brief cases must also be checked in at the Lucky North® Club Desk located at the Main Entrance.

PROHIBITIONS

You must not:

- 1. Engage in any illegal or undesirable behaviour at Mindil Beach Casino & Resort.
- 2. Bring into Mindil Beach Casino & Resort weapons or any items considered offensive.
- 3. Leave minors unattended when you enter Mindil Beach Casino & Resort.
- 4. Enter Mindil Beach Casino & Resort if you are an Excluded Person.

ITEMS NOT PERMITTED

- 1. Two-way radios or scanning devices.
- 2. Any object considered an offensive implement or weapon.
- 3. Alcohol, food or drink.
- 4. Baby prams (applicable to the gaming area only).
- 5. Flags with flag poles.
- 6. Large bags exceeding 'commercial airline carry-on baggage size limits or (56cm [height] x 36cm [width] x 23cm [depth]) (excluding within the hotel).
- 7. Large umbrellas.
